INSURANCE

I understand that except as otherwise agreed in writing, that Christ Fellowship Church, Inc. does not carry or maintain health, medical, disability, damage, liability, or other insurance coverage for the benefit of any volunteer and expressly disclaims the responsibility or obligation to do so.

As a volunteer, I am expected and encouraged by Christ Fellowship Church, Inc. to maintain medical, health, and all other applicable insurance coverage for my own benefit.

MEDICAL TREATMENT

I hereby release and forever discharge Christ Fellowship Church, Inc. from any and all claims, demands and causes of action whatsoever that may arise or may hereafter arise on account of any first aid or other medical treatment rendered in connection with volunteer activities.

I understand that my participation with Christ Fellowship Church, Inc. and/or any project, activity or event sponsored, managed, arranged or promoted by, or otherwise affiliated or associated with Christ Fellowship Church, Inc. may include activities that may be hazardous to me.

I further recognize and understand that such participation may involve certain inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in the activities and release Christ Fellowship Church, Inc. from all liability for injury, illness, death and/or property damage that may result.

PHOTOGRAPHIC RELEASE
